Mayor Collings presented Emergency Ordinance 2023-15 to Amend Appropriations to Cover Expenses. Abe Arnold made the motion to waive the three reads and adopt Ordinance 2023-15, seconded by Beth Grehl.

Public Comments: A resident is upset about issues with the railroad and its upkeep.

Council Comments Abe Arnold spoke about an Ordinance being drafted by the lawyer regarding Juneteenth and New Year’s Eve. He would like it to say that an unapproved holiday (Juneteenth) was observed without Council approval and because of that another approved holiday (New Year’s Eve) should be forfeited, keeping the total number of observed holidays for employees at 88 hours, per the employee handbook. The following year, New Year’s Eve will not be observed, but employees may use a floating holiday in its place. David spoke and clarified the Ordinance. The Ordinance will be placed on the next Council meeting’s agenda.

Vicki Mongold wanted to thank Jordan for attending the Appropriations and Budget meeting and answering her questions. It was very helpful, and she appreciated it.

Beth Grehl wanted to remind everyone to keep Bruce in their thoughts and prayers.
