AN ORDINANCE CREATED FOR THE PURPOSE OF THE REGULATION OF PEDDLERS AND SOLICITORS WITHIN THE CORPORATION LIMITS OF THE VILLAGE OF SABINA

WHEREAS, the Village Council desires to adopt this ordinance to regulate peddlers, and solicitors by requiring them to register with the Sabina Police Department in accordance with Ohio Revised Code 715.61.

WHEREAS, such action is in the best interest of the health, safety and welfare of the community as a whole.

THEREFORE, BE IT ORDAINED by the Council of Sabina, Clinton County, Ohio with two thirds of all Council members concurring thereto, as follows:

Section One: It shall be unlawful for any peddler or solicitor to engage in business without registering with the Sabina Police Department before conducting the said business in the Village of Sabina.

Section Two: Exemptions to this ordinance are:

- a) People who are invited to visit an owner or tenant's premises to sell, offer for sell or solicit orders for future delivery of goods.
- b) Vendors who sell and deliver goods to local businesses on a regular basis.
- c) Persons only collecting money for goods previously ordered or sold.
- d) Girl Scouts, candidates running for election, school and church organizations selling goods, raffle tickets, etc.

Section Three: Applicant is required to submit the following information to the Sabina Police Department by the passage of this ordinance:

- a) Name, home address, date of birth and telephone number of the applicant.
- b) Description of the nature and purpose of business, promotion and solicitation of goods or services offered.
- c) Name, address and telephone number of direct supervisor of employer of affiliated organization.
- d) Provide Driver License, State ID or other form of identification.

Section Four: Door-to-door solicitors must perform their solicitations between the hours of 9:00 A.M. and 6:00 P.M. Monday through Saturday. Solicitation is prohibited on Sunday and holidays.

Section Five: Solicitors shall not harass or annoy potential customers or residents and adhere to "No solicitor or Peddler" signs clearly posted by residents. Any signs put in the yards shall be removed after any events.

Section Six: The Village of Sabina shall maintain a "no contact list" of residents who do not wish to be contacted by such peddlers or solicitors and will provide the list to the peddlers or solicitors. Anyone failing to honor the list should be reported to Police.
