

COUNCIL COMMENTS: Mayor Mongold asked if the Council would like to purchase brackets for the Military Banners because when people bought the banners they thought the brackets would be included. The cost totals at \$5,000 and Mrs. Sears has gotten \$2,500 so the Village would only be responsible for the other \$2,500. Mrs. Grehl stated that there is a grant for a \$1,000 reimbursement that she learned about at her new Council members meeting in Mason, Ohio. Mr. Collings talked to the Library about a community garden and they are interested in helping. Additionally, Mr. Collings asked where the trashcans went that were on Main Street. Mr. Dean stated that people were using it as a personal trash service so he put them away. Mrs. Grehl asked what the Council thinks about giving free pool days on the days with heat advisories. Mr. Dean suggested that those are the days where the most money is made.
